

# FERC 63 Nomination Procedure



## PREFACE

This ***Nomination Procedure*** is a reference document provided by UGI Central Penn Gas, Inc. ("CPG"). This nomination procedure has been designed to assist shippers in the areas of nominating, scheduling, and communicating specific information which CPG may require from shippers who have executed a Transportation Service Agreement with CPG. These guidelines and procedures may be modified from time to time to reflect FERC and/or CPG procedural changes or personnel changes. If such revisions occur, a revised copy of this document will be posted to CPG's Gas Management website located for reference at <http://gasmgmt.ugi.com/UGIC/indexprocedures.shtml>.

## NOMINATING AND SCHEDULING

### 1. Method of Placing Nominations

All nominations must be submitted to CPG via electronic mail to [CPGFERC63noms@ugi.com](mailto:CPGFERC63noms@ugi.com). See Exhibit A for nomination template.

### 2. Deadline for Nominations

The deadline for nominations is 12:30 p.m. EST on the Intercontinental Exchange trading day for the applicable gas flow day(s). The actual time for all nominations will be the system date and time the email is received on CPG's mail server.

### 3. Allocation of Nominations

The allocation of capacity will be subject to CPG's ability to confirm the receipt of gas with upstream parties and the delivery of gas with downstream parties. If nominations exceed the quantity of gas that can be confirmed with interconnecting operators, nominations will be reduced to the quantity confirmed with interconnecting operators. Further, if nominations exceed CPG's operational capacity for the day, CPG will reduce nominations accordance with the provisions of its Statement of Operating Conditions. Nominations received after the deadline will be allocated, or prorated if necessary, based on intraday availability after timely nominations have been allocated.

### 4. Confirmation of Nominations

The Shipper must provide CPG an email address for the purpose of sending a confirmation of each submitted email nomination. A final confirmation will be sent by CPG to the Shipper after the gas day is complete confirming the scheduled flowing quantity and rate.
